**LOCK BOX AGREEMENT**

Pacific County Fire District No. 1 provides lock boxes and assists with their installation as a public service to the residents of the community. The lock boxes are not warranted in any manner by the department, and the department does not adopt any warranties issued by the manufacturer. The department does not certify or warrant the installation of the lock box.

The undersigned understands that their personal house key will be placed in the lock box and that PCFD#1 will only open the lock box for the purpose of gaining entry to assist the occupant in an emergency situation. An emergency situation shall include: 9-1-1 call, any call by a third party requesting a general welfare check, a request from an alarm monitoring company.

The undersigned acknowledges that he or she has inspected or has had the opportunity to inspect the lock box and accepts it as supplied and under the conditions expressed above. The undersigned further releases and agrees to hold Pacific County Fire District No. 1, its officers, agents, and employees harmless from all damages to property or personal injury, of whatever nature incurred, as a result of, or during the course of performing the installation of the lock box, or as a result of the District gaining entry for emergency assistance.
